After reviewing the board approved rates for this year, and we found an error for the standard tap and 3/4" estate tap monthly rates. These current rates will be implemented for water used in January - so February bills. For the standard tap the tier rates are correct, but the gallons are not, and the base rate is wrong. For the ³/₄ Estate tap there was a tier missing. Also after discussion we originally bumped up the Base rates for non-residential 8%, after reviewing again our Rate Study in February of 2023 we realized that that Willdan had bumped those tier rates up higher and to follow suit for revenue stability we are adjusting those base rates to match the recommendations of Willdan.
