Smart Irrigation Controller

Little Thompson Water District recommends WaterSense labeled irrigation controllers to significantly reduce overwatering by applying water only when plants and/or grass needs it. Residential outdoor water use in the U.S. adds up to about 8 billion gallons of water each day. Experts estimate that upwards of 50% of this water is wasted due to overwatering from inefficiencies in irrigation methods and systems.

How to care for a water efficient lawn:

Keep your grass longer! Long grass, 3+ inches, provides better insulation from summer heat, reducing water loss.

Be sure to water before 10 am or after 6 pm and only on your mandatory watering days. Please check current action level meter at https://littlethompsonwd.colorado.gov/ to determine how frequently you can water.

A fun fact about grass: it goes dormant in periods of drought. During higher water restrictions, your grass will turn brown, but it won't die!

More than half of residential water use comes from outdoor use. Well-planned landscapes help conserve water by improving soil properties, planting low-water use plants, and maintaining efficient irrigation or sprinkler systems.

Finding a Smart Irrigation Controller

Your landscape contractor, local garden nursery, or home and garden store can help you choose a smart irrigation controller. Make sure your smart irrigation controller is EPA approved by looking for the WaterSense label.

- Download the Eye On Water App and provide the water usage from the 5th of the previous month
