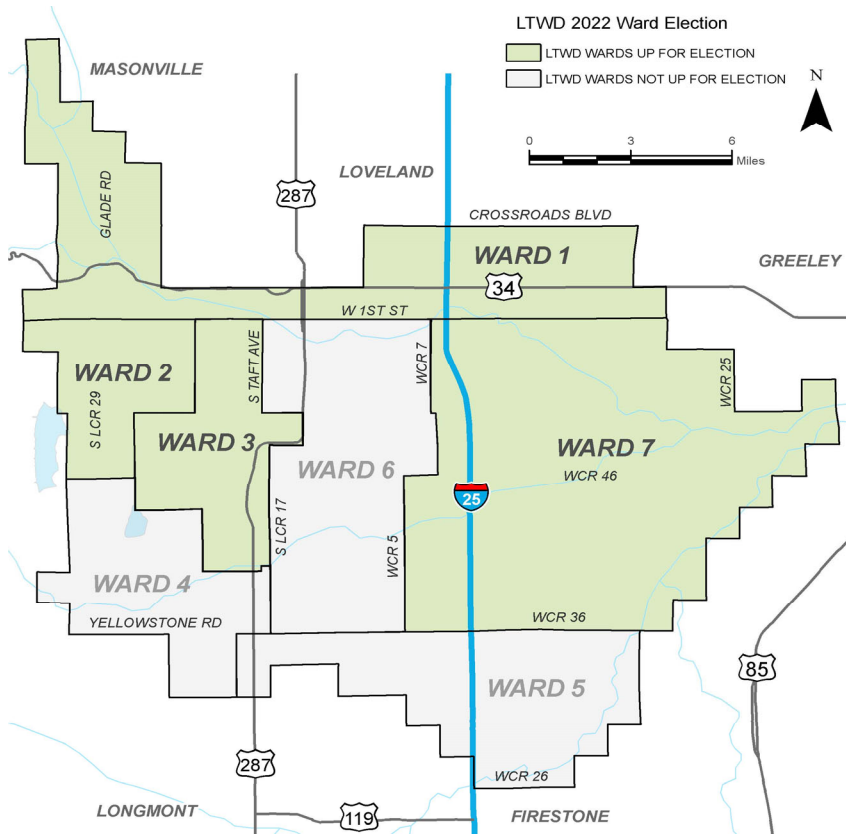

## SPRING 2022 NEWSLETTER

### REGULAR DISTRICT ELECTION

Little Thompson Water District (District) operates as a Special District in the State of Colorado under Article 1 of Title 32 of the Colorado Revised Statutes, which is the general source of most of the statutory authorization including elections. Regular Special District Board of Director Elections are held on the Tuesday following the first Monday of May in even-numbered years, but starting in 2023 they will be held in odd-numbered years. The next election is scheduled for May 3, 2022.



The Board of Directors (Board) is composed of seven members who represent seven designated Wards within the District. At left is the District’s Director Boundary Map outlining the wards. For the May 2022 Election the following seats are up for election: Ward 1, Ward 2, Ward 3, and Ward 7. The four Directors will be elected to serve 3-year terms.

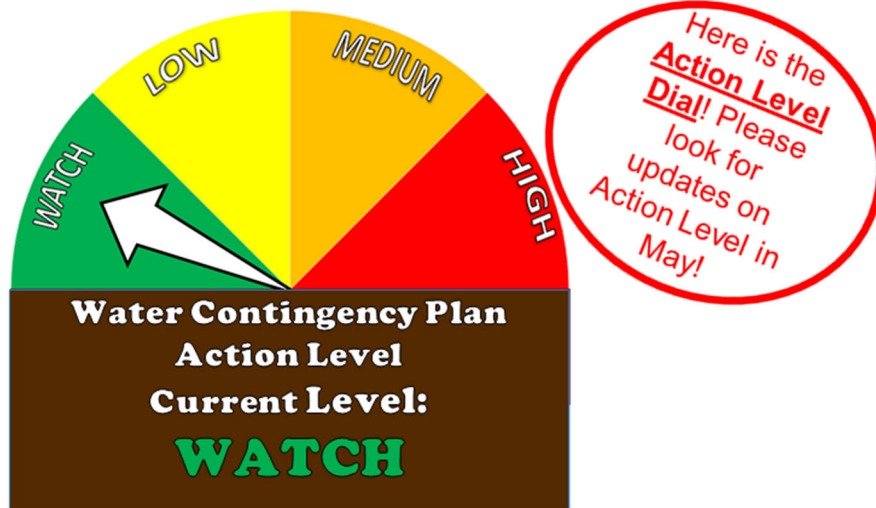
Electors vote “at large”, meaning electors vote for their choice of one candidate in each of the four Wards, as well as on any Ballot Question. To be eligible to vote in the District Election, you must be a registered elector in Colorado, and reside or own (or whose spouse/civil union partner owns) taxable real or personal property within the boundaries of the District, the property must be in the name of a real person (not a trust, LLC, corporation, etc.), and Little Thompson Water District must be listed as a Taxing Authority for the property in the county assessor’s records.

In-person polling will be held at the District office located at 835 E. Highway 56, Berthoud, CO 80513, on Tuesday, May 3, 2022, between the hours of 7:00 a.m. and 7:00 p.m. Electors wishing to vote via Absentee Ballot must complete an Application for Absentee Voter Ballot. The application may be requested from Judy O’Malley, Designated Election Official, via email (jomalley@ltwd.org) or phone (970-344-6306). The application is also available on the District website (<https://littlethompsonwd.colorado.gov/board-election-information>). Completed applications must be received at the District office by Tuesday, April, 26, 2022, no later than 5:00 p.m.

Board meetings are generally held on the second Thursday of each month at 5:00 p.m. and are open to the public.



At the December 9, 2021, Regular Board Meeting, the LTWD Board of Directors approved the Water Shortage Contingency Plan (plan).
